FREJA EID RELEASE NOTES

These Release Notes describe all the changes made to the Freja eID systems from the previous release. They include:

- Changes from version 5.8.0 to 5.9.0 of the Freja eID mobile app on iOS.
- Changes from version 5.10.0 and 5.11.0 of the Freja eID mobile app on Android


SUMMARY

- USER AGE POPUPS We want Freja eID to be a digital e-ID for people of all ages. In this update we are making changes to how minors register for Freja eID. Children under 8 will not be able to add an ID document to Freja eID, while children of ages between 8 13 must have their parents' permission first.
- NATIONAL ID/TAX ID RECOGNITION We have discovered that some people are making the mistake of adding their Tax ID even though they chose the Swedish National ID document previously. We are making improvements to this flow to help guide users to the correct document.

USER AGE POPUPS

Freja eID is a digital identity for people of all ages and now it will be clearer in the app which services are available to different age groups. Children under the age of 8 will not be able to add an ID-document and children between 8 and 13 will need explicit consent from their parents. Please note that users under the age of 8 will still be able to use Freja eID for services that do not require an ID document to be added.

When a child under the age of 8 attempts to add a document to Freja eID, they will receive the following popup:



When it comes to children between the ages of 8 and 13, they may add a document to Freja eID after having gotten permission from their parents. When the app detects that the user is between the ages of 8 and 13, they will be shown the following popup:




After confirming that they have their parents' permission to add a document to Freja eID, they may continue registering normally.

NATIONAL ID/TAX ID RECOGNITION

As the number of people using Freja eID keeps increasing, we have noticed that some people confuse their Tax ID (Skatteverkets ID-kort) with their National ID document. What happens is that they choose to add their National ID to Freja eID, but then actually start adding data from their TAX ID card instead.

It is possible for us to recognise that this is what they are doing, so when they make this mistake, we can tell them what to do. When the app detects that the user is entering the wrong data, the following popup will appear:



The user will have the option to continue entering the data from their Tax ID card, or to choose another document to Freja eID. This change should contribute to considerably less errors for users who wish to add their document to Freja eID.
