FREJA EID RELEASE NOTES

These Release Notes describe all the changes made to the Freja eID systems from the previous release. They include:

- Changes from version 6.1 to 6.2 of the Freja eID mobile app on iOS.
- Changes from version 6.1 and 6.2 of the Freja eID mobile app on Android

Summary

- Updates to Personal eID Freja eID users in Sweden will now have the option to also share their personal ID number (personnummer) with others in order to prove their identity;
- Improved Security on Personal eID We have added visual and audio effects to the personal eID in Freja eID. This security measure ensures that the personal eID is protected from fraudsters.

Updates to Personal eID

We are continuing to develop and expand Freja eID's functionalities. That includes building upon the personal eID found in Freja eID, with which users can prove their identity and share their data with others.

The latest update brings the option for people to share their personal ID number in order to prove their identity.

Procedure

When users open their personal eID for the first time, they will be greeted by an updated info screen explaining the different use cases for their personal eID wherein they can:

- 1. Share their personal ID number (personnummer)
- 2. Share their name, age and photo

There are also instructions about how to check screen authenticity via liveness (audio and visual cues that act as a secutity measure to prove that the screen is real) that was added in the previous update to Freja eID.



This info screen will be shown to users only once, when they open their personal eID for the first time.

After that they will get a menu where they will be able to select what data they wish to generate for sharing/proving their identity. The options here mirror the ones explained previously i.e. they may opt to generate a shareable screen with their personal ID number, or one with their name, age and photo.

Note that there is also the option to begin the process for getting Freja eID Plus here. Users may still begin this process from the home screen or from Settings if they wish.



After selecting what data they wish to generate, they will get the screen they wish with their data.

The personal ID number screen

As mentioned above, the primary function of this screen is to show the user's personal ID number. Apart from that, the user's name and photo will be there, but they will not be shareable via the QR code. People will always know what they are sharing as that will be written in the bottom of the screen.

This screen can be shared in two ways:

- 1. Showing the screen
- 2. Letting somebody scan the QR code




The QR code containing the personal ID number will also have a time limit as an additional security measure. The time limit is 120 seconds, and users will always be able to refresh the QR code so they can share it if they need to.

Sharing age, name and photo screen

The primary function of this screen is to allow people to share their age, name and photo. As this data is not as sensitive as the personal ID number, there is no timer on this screen. Again, the data they are sharing can be seen at the bottom of the screen.

This screen can be shared in the following ways:

- 1. Showing the screen
- 2. Letting somebody scan your QR code
- 3. Using the share icon in the bottom right corner



Sending a link to your data is possible via email, SMS or social media. Also, the person you are sending your data to does not need to have Freja eID in order to see it.

Improved Security on Personal eID

We have also added visual and audio effects on the personal eID screen as a security measure that helps prevent fraudsters from taking advantage of biometric security measures.

When users interact with the screen e.g. by tapping on it or swiping on it, there will be a visual effect as well as a sound that plays, thus making it apparent that the screen is authentic.
