FREJA eID RELEASE NOTES

These Release Notes describe all the changes made to Freja eID systems from the previous release. They include:

- Updates to the Freja eID mobile application from version 6.20 to 7.0 on both Android and iOS.

Summary

- COVID CERTIFICATES IN FREJA eID

We have added the flow and UI components needed for people to add the Covid Certificate to Freja eID. **NOTE!** The possibility to add a Covid Certificate is expected from 1 July this year from the official [eHälsomyndigheten](https://www.ehalsomyndigheten.se) website.

Covid Certificates in Freja eID

In this release, we have laid down the groundwork in preparation for Covid Certificates that are expected to become available soon. **It is important to note that adding a Covid Certificate to Freja eID is not possible yet. This depends eHälsomyndigheten setting up the infrastructure for citizens to scan the QR code that contains the actual Covid Certificate.**

WHAT IS A COVID CERTIFICATE?

A Covid Certificate (previously known as the Green Certificate or covid passport) is proof that someone has received a Covid-19 vaccine. It has been introduced to help the free movement of people within the EU.

WHEN WILL IT BE AVAILABLE?

According to the latest statements from the EU and eHälsomyndigheten, it should be available from eHälsomyndigheten's official website from 1 July via a QR code.

As far as Freja eID is concerned, Covid Certificates can be added as soon as the functionality is implemented by eHälsomyndigheten.

HOW WILL USERS ADD THEIR COVID CERTIFICATE TO FREJA EID?

People will be able to scan a QR code on eHälsomyndigheten's official website containing their Covid Certificate. In this way, their Covid Certificate will be stored in Freja eID in digital form.

HOW CAN PEOPLE USE THEIR COVID CERTIFICATE WITH FREJA EID?

Once stored in Freja eID, people will be able to share their Covid Certificate data in 2 ways:

1. By showing their screen, as the relevant data will be displayed upon it.
2. By allowing someone to scan their QR code should someone need a record of that data.

The screen contains a liveness feature as a security measure to prove that the screen is authentic and not a screenshot.

HOW IS DATA FROM THE COVID CERTIFICATE HANDLED?

Adding a Covid Certificate to Freja eID is only done with the explicit consent of the user. The storage and handling of that data is done in accordance with our updated Privacy Policy. The sharing of that data with any third party is done only with the explicit consent of the user.
